BE IT KNOWN, on this 8th day of August, 1978,

before me, the undersigned notary public, in and for the parish and state aforesaid, personally came and appeared:

SHENANDOAH CORPORATION, a Louisiana Corporation, domiciled in East Baton Rouge Parish, Louisiana, represented herein by W. T. Harger, its President, duly authorized to act on behalf of the corporation,

who after being duly sworn, declared that by act passed before Roland C. Kizer, Jr., Notary Public, under date of July 13, 1978, recorded as Original 920, Bundle 9271 of the official records of the Parish of East Baton Rouge, Louisiana, the said Shenandoah Corporation established the

Subdivision Restrictions for Shenandoah Estates Subdivision, Eighteenth Filing, Part I. That throughout the body of said Restrictions, the Lot Numbers referred to as being a part of Shenandoah Estates Subdivision, Eighteenth Filing, Part I were Lots 1447 - 1487, when in truth and fact, the Lot Numbers which comprise Shenandoah Estates Subdivision, Eighteenth Filing, Part I are actually Lot Numbers 1410 - 1446, as shown on the final plat thereof for Shenandoah Corporation, by Edward E. Evans & Associates, Inc., C.E., recorded in the official records of the Parish of East Baton Rouge as Original 254, Bundle 9273. That there was a clerical error committed in the preparation of said Restrictions, by the declaration of the incorrect Lot Numbers. That in view of the foregoing and for the same consideration originally recited, appearer has agreed to reform and correct the aforementioned Restrictions for Shenandoah Estates Subdivision, Eighteenth Filing, Part I, to confirm that the lots affected thereby are:

LOT NUMBERS ONE THOUSAND FOUR HUNDRED TEN (1410) through ONE THOUSAND FOUR HUNDRED FORTY-SIX (1446), inclusive.

AND, I, NOTARY, do hereby authorize and request the Registrar of Conveyances and Recorder of Mortgages to make mention of the within Act of Correction in the margin of his records in East Baton Rouge Parish, Louisiana, to serve as occasion may require.
