AMENDMENT TO RESTRICTIONS, SHENANDOAH ESTATES SUBDIVISION, 23RD FILING

STATE OF LOUISIANA  
 PARISH OF EAST BATON ROUGE

BE IT KNOWN that on this 7<sup>th</sup> day of October, 1985, before me, the undersigned Notary Public in and for the Parish and State aforesaid, and in the presence of the undersigned competent witnesses, personally came and appeared:

QUAD A DEVELOPERS PARTNERSHIP, a Louisiana partnership, composed of Jerril A. Musso, John R. Musso, Randal G. Lissard and Eugene J. Lissard, represented herein by Jerril A. Musso and Randal G. Lissard, duly authorized by virtue of Agreement of Partnership on file and of record in the office of the Clerk and Recorder for the said Parish and State,

hereinafter referred to as "Appearer", who did declare that:

Appearer is the owner of all of the lots in Shenandoah Estates Subdivision, 23rd Filing, a subdivision situated in the Parish of East Baton Rouge, Louisiana, which lots are numbered as LOTS TWO THOUSAND THREE HUNDRED SEVENTY-TWO (2372) through TWO THOUSAND FOUR HUNDRED TWENTY-SIX (2426), inclusive, and the subdivision is in accordance with the official plan of Shenandoah Estates Subdivision, 23rd Filing, prepared by Evans-Graves Engineers, Inc., dated July 22, 1985, which plan is on file and of record in the office of the Clerk and Recorder for the Parish of East Baton Rouge, Louisiana.

Shenandoah Corporation has heretofore, by agreement dated August 20, 1985, established protective covenants and restrictions affecting all lots in Shenandoah Estates Subdivision, 23rd Filing, which restrictions are recorded as Original 852, Bundle 9773, of the official records of East Baton Rouge Parish, Louisiana.

Appearer does hereby amend the above described protective covenants and restrictions affecting Shenandoah Estates Subdivision, 23rd Filing, as follows:

Paragraph 12.1 shall be amended to delete the original members of the Shenandoah Estates Subdivision Council and to substitute the following members so that it reads in its entirety as follows:

"12.1 The Shenandoah Estates Subdivision Council, Twenty-third Filing, is hereby established and shall be composed of three members. The first three members of the Council shall be:

- Jerril A. Musso - Baton Rouge, LA
- John R. Musso - Baton Rouge, LA
- Randal G. Lissard - Baton Rouge, LA

Said council is hereby granted the responsibility and authority in its sole discretion to approve the architecture and design of the buildings so as to comply with these restrictions."

In all other respects, the original restrictions dated August 20, 1985, and recorded as Original 852, Bundle 9773, shall remain in full force and effect as originally written.
